B. State Report

- 1) Craig Amey presented the State Report.
- 2) Craig briefly discussed the Model Law used by NCEES that is being reviewed by state societies in protecting surveyor's work.
- 3) The state board has two new board members. Ginger Michalski-Wallace with Alpine Engineering and Michael G. an instructor at MTU.
- 4) Continuing Education requirement is being processed at the state level. The rules are currently being worked on. The approval of the rules is approximately set for September of 2012.
- 5) The board reported a profit of \$20,700 from the 2012 Annual Meeting hosted by the Southeast Chapter.
- 6) Karol Grove is the Seminar Chair for the upcoming year. A couple of possible seminars are being discussed. One is related to "Laws and Amendments in Michigan and Continuing Education". The other is related to the "Michigan and Indiana Border". Another possible traveling seminar would involve Realtors, Attorneys, and Surveyors.
- 7) Continuing Education at the NSPS Convention is also being discussed.
- 8) The board has established a "Legal Offensive Fund" in pursuit of unlicensed surveying activity in the state. Progress was made in the U.P. regarding a well driller who was certifying well locations with respect to property lines. The board is still looking for support for the fund as they continue their efforts. The typical cost in hiring an attorney to send letters to the individual involved in the unlicensed activity is around \$1500.
- 9) Tim Platz has met with MDOT to discuss the Act 132 requirements as they relate to land conveyance. Currently, MDOT does not follow the requirements of Act 132 as they relate to land conveyance and the board is making an effort to get this corrected.

- 10) There are two upcoming state bills that relate to Professional Surveyors. Members are urged to contact their local congressperson regarding the bills. One is Senate Bill 1038 which is the "Lien Law" bill. Currently, surveys and monuments are not considered improvements to property under the law and thus surveyors are unable to place liens on property. The other is House Bill 5466 which is the "Indemnity Law" bill. This bill is an effort to only hold the professionals involved in projects responsible for their part in the project, not for the work done by all professionals involved in the project.
- 11) MSPS will be voting on some Bylaw changes in June. One of the proposed changes involves allowing for Community College students to become student members of MSPS.
- 12) Craig also attended the recent NSPS board meeting in North Carolina. A couple items that are being discussed at the national level are the "Certified ALTA Surveyor" program and a joint NSPS and state membership program.

C. Golf Outing
